Updated Minimum Quarantine Timeframes

On March 23rd the NJDOH updated the Recommended Minimum Quarantine Timeframes. 14 days is always preferred as the best way to prevent COVID-19 transmission.

Outside of high-risk congregate settings, close contacts of a COVID-19 positive case should quarantine UNLESS:

- Individuals who are fully vaccinated, OR
- Persons who clinically recovered from COVID-19 in the past 90 days

The recommended minimum timeframes for quarantine vary by level of community transmission:

- Very High/High: 14 days where feasible.
- Moderate/Low: 14 days is preferred. The alternative quarantine time frames are acceptable.

What about travel? Travel has been a big question as we approach spring break. All travelers (including essential workers such as healthcare personnel) should continue to follow all New Jersey and CDC travel recommendations, including the recommendations for travel and quarantine post-travel INCLUDING:

- Individuals who are fully vaccinated, OR
- Persons who clinically recovered from COVID-19 in the past 90 days. This has changed from previous guidance.

Individuals traveling are recommended to get tested before and after traveling and should quarantine upon return from their travel. This includes all travel outide the immediate area (NY, CN, PA), spring break trips both domestic and international and college visits out of state.

NJDOH School Guidance Updated

On March 23rd the NJDOH Updated the K-12 School Guidance. Here are some key updates:

- On March 19th, CDC released Science Brief: Transmission of SARS-CoV-2 in K-12 schools which summarizes evidence on COVID-19 among children and adolescents and what is known about preventing transmission in schools.
- The CDC also released <u>Operational Strategy for K-12 Schools</u> <u>through Phased Prevention</u> which outlines revised guidelines for physical distancing recommendations to reflect at least 3 feet between students in class.
- The NJDOH has updated the school guidance to reflect distancing recommendations to reflect at least 3 feet between students in classrooms and provide clearer guidance for when greater distance (6 feet) is recommended.
- What's changed? COVID-19 has not changed. The
 distancing recommendations in the current guidance aim to
 balance risk of disease transmission with the benefit of
 offering in-person instruction to as many children as possible.
- Full in-person instruction means to open to as many students as possible with mitigation strategies in place – minimum social distancing, universal masking, cleaning, hand hygiene and other strategies.
- Outside of classrooms 6 feet of physical distancing should be implemented elsewhere in the school building.
- Mask wearing should be always enforced.
- Airflow in schools should be maximized.
- COVID-19 Regional Risk Matrix Recommendation Updates:

 - Middle/High School: For Low and Moderate Risk levels

 full person instruction with minimum of 3 feet of physical distancing between students in classroom with strict adherence to mask-wearing. For High Risk levels in-person instruction with physical distancing of 6 feet or more with strict adherence to mask wearing.
