# **2019 Novel Coronavirus (COVID-2019) Weekly Update #47 – October 20, 2020**

#### **COVID FAQ Corner**

Every day the Bernards Township Health Department receives calls from residents, school nurses, parents and other members of the community. Every week we'll compile these Q&As for our "COVID FAQ Corner".

## Q: The weather is getting colder, but I still want to see my family and friends. Can we gather inside?

A: There has been an increase in transmissions associated with small gatherings, especially indoors. Indoor gatherings should be limited to immediate household members. Continue to plan parties outdoors.

### Q: My family went to visit a college in (State on Travel Advisory List). Do we have to quarantine?

A: There are currently <u>38 states</u> on the travel advisory list. Anyone leaving New Jersey to travel to a state on that advisory list should quarantine for 14 days upon return. This also goes for college students returning home for a visit. We have seen college students infect parents and siblings.


# Q: I'm a parent and I recently had an exposure to a positive COVID-19 case. Should I keep my kids home from school if I'm starting to have symptoms but haven't gotten tested yet/gotten my results?

A: Yes. If you had an exposure to a positive COVID-19 case, you should quarantine at home for 14 days. If you start to have symptoms you should keep your children home and get tested. If you haven't had symptoms or tested positive, your children can continue to attend in-person instruction.

## Q: When should I get a PCR (molecular) test as opposed to a rapid (antigen) test?

A: If you are getting a rapid test and you have had <u>no known exposure</u> to COVID and you receive a negative result, it is more than likely correct. If it's positive, you should treat it as a positive and quarantine immediately. If you <u>had exposure to a COVID-19 case</u> and the test is negative, we would recommend getting a PCR (molecular) test to be sure. #### **Quarantine Bubbles**

Over the past several months many families have designated their "quarantine bubble" or have limited who their family interacts with in person. While this is a safer practice, the Health Department wants to remind everyone that those selected people also have their own "quarantine bubble" and it doesn't take long for a case from one bubble to connect to another. Keep open lines of communication with your friends and family stop the spread of COVID-19.

#### **Updated Sports Guidance – 10/12**

No-contact practices, contact practices and competitions are allowed for sports defined as "Low Risk", "Medium Risk" and "High Risk" and are permitted in both indoor and outdoor settings. 
